#### Sarasota Bay Estuary Program (SBEP) to Support Restoration at North Water Tower Park

SBEP and its partners have been approved for an EPA Gulf of Mexico Partnership Grant for restoration at North Water Tower Park. The \$300K grant supports stormwater improvements, removal of invasive vegetation, planting Florida native plants, and education outreach. The 20-acre park was established in 2003.

Partners and supporters for the three-year project include The City of Sarasota and its Urban Design Studio, Sarasota County, The North Trail Redevelopment Partnership, Bayou Oaks Neighborhood Association, Indian Beach-Sapphire Shores

Neighborhood Association, and Professional Disc Golf Association. The neighborhood associations represent local residents and the PDGA supports the popular disc golf course located in the park.

Bay Guardian projects are coordinated by Around the Bend Nature Tours. # Southwest Florida Water Management District (SWFWMD) Cooperative Funding Applications

The County submitted SWFWMD Cooperative Funding Applications for two projects that are of interest for the Indian Beach-Sapphire Shores Neighborhood Association. Both applications are ranked HIGH and the County will know by October 1, 2014 if the projects receive funding.

#### North Water Tower Park Stormwater Improvements (\$1M)

Improve Whitaker Bayou which drains to Sarasota Bay, a Surface Water Improvement and Management (SWIM) waterbody, by treating stormwater runoff through improvements to the water features in the park. The project would provide stormwater treatment for almost 100 acres of highly urbanized commercial area in downtown Sarasota to reduce nitrogen going into the Bay.

#### Indian Beach-Sapphire Shores Bioretention (\$160K)

Improve the water quality in Sarasota Bay, a SWIM waterbody, by

treating stormwater runoff through LID improvements in the Indian Beach-Sapphire Shores neighborhood through a collaboration with the Sarasota Bay Estuary Program and the Neighborhood

bioswales at select locations in the right-of-way. The project would provide treatment for over three acres of medium density urban area to reduce nitrogen going into the Bay.

#### MEET YOUR NEIGHBOR: Richard Suder (Ingrid), Sapphire Drive



You mentioned that you have many stories from your life. One of them was about a dangerous sea adventure when you were living in Angola. Can you tell me that story?

My friend, Claus, and I went to the club early one morning to go

fishing offshore with his 12' boat, and we planned to return by noon. We took a couple bottles of beer, a bottle of water, and a couple of sandwiches. We couldn't get his boat started. At that time, we used regular leaded gasoline because the marine white (non leaded) was hard to get. Unfortunately, regular gasoline would sometimes foul the plugs on a two-stroke engine. We decided to switch to my boat; a little 10' one that I had built for the rivers and not meant to go into the open ocean. Because of the boat switch, I didn't have my tool kit, compass, or extra supplies with me. We caught some flying fish; which are great bait for sailfish and since we were in a very good offshore area for sailfish, we rigged the flying fish (ballyhoo) and decided to troll out 15-20 miles offshore. While we were fishing, the engine fouled. I managed to get the spark plug out of the motor with fishing pliers and cleaned the points off with a bandana. It started up again, but fouled once more. This time I cleaned it with a filet knife, scraping the points. The motor started, but went down again several times, and eventually wouldn't start. It was around 11am and we were about 20 miles offshore. The boat had two rod holders, so we put the rods in the rod holders. I had two oars in the small boat for emergency use, but I didn't have any oar locks. We took off our belts, wrapped the belts around the oars and the fishing rods, and used those as oar locks. I took off my shirt and hung it from one of the fishing rod ends as a flag for a distress signal. We started rowing, Claus on one side and me on the other. After three hours of rowing, the wind picked up and we could see a big, black bank of clouds and a storm approaching from the southwest. The sea waves picked up to 2-3', and we started taking on water. The storm kept approaching, and we kept rowing. We were getting closer to shore, except we were being pushed by the wind and the current to the north of the city, which was terrorist country. After a while, Claus couldn't row anymore, so I handed him a tin cup and asked him to start bailing water. I closed my eyes, got into a zone, and kept rowing. By 4 or 5pm, several boats had passed us, but we were so small that they couldn't see us. The seas picked up to

about 4-5' and it was getting dark. Thunder, lightning, and rain started. I rowed another hour and estimated we were around 10 miles north of the city from where we started. I didn't want to row into the waves because we would take on more water, and we already had about a foot of water in the boat. Claus couldn't bail fast enough. I was about ready to jettison the motor, just to stay afloat. Then, low and behold, over one of the 7' tall waves came a 100' long Portuguese wooden fishing boat. They saw us and realized we were in distress and needed help. They were headed south to go on a fishing trip to the Kwanza River. We boarded their boat and then the fishermen on board reached over the side, picked up our boat and threw it onto the deck of their fishing boat. After rowing all day with only a beer each and a bottle of water, we were extremely thirsty. The water the Captain kept in a large glass jar tasted wonderful. It was a miracle that they found us and took us back to shore. I didn't have any money on me, but I did have a favorite German (Junghans) gold pocket watch that I gave them for saving us.

#### Where were you born?

I was born in the East New York section of Brooklyn to Lithuanian parents. My wife, Ingrid, was born in Gotha, Germany.

Where have you lived and worked prior to moving to the Indian Beach-Sapphire Shores neighborhood?

Prior to arriving in Sarasota, we lived in São Brás de Alportel, Portugal (in the Algarve); Connecticut (Fairfield, Westport, and Westin); New York (Bedford Village and Croton); Austria (Aigen-Voglhub between St. Wolfgang and Bad Ischl); Aachen-Germany; and Madrid, Spain. We also lived in the Ivory Coast, Venezuela, Brazil, Cameroon, Angola, and Benin.

In my professional life, I supplied oilfield and gas turbine parts to the Middle East, Africa, Indonesia, Malaysia, and South America. I traded crude oil and refined products including back-office operations, shipping, importation, and exportation. I was the Division General Manager for Texaco for refined product marketing and operations in Equatorial Africa, Venezuela, and Vice President for Operations in Brazil.

I established small business and refugee projects in Africa. I was a Texaco representative on the Board of Directors for local (SUDER continued on page 7)



## BILLY BOWLEGS AND THE BANANA PATCH

Last year, a friend in Indian Beach pointed to a banana tree in his yard and said it was directly descended from the banana patch of Chief Billy Bowlegs. It was a gift from a friend who has been propagating bananas from a patch she played in as a child. It came from a place she called "the bluff".


Thinking it was somewhere near the old Whitaker Homestead between Whitaker Bayou and Indian Beach Drive, I started to dig a little deeper. I tracked the banana donor down only to find out her "bluff" was closer to another 19<sup>th</sup> century settlement down near Cunliff Drive and Osprey Drive. She recalls exploring a banana patch with her brother 50 years ago that was so expansive it surely took a century or more to grow.

The significance of Billy Bowlegs' banana patch has everything to do with the start of the 3<sup>rd</sup> Seminole War in 1856. That's when some surveyors (or soldiers, depending on your perspective) set out from Ft. Myers to locate what few remaining Indian settlements existed on our coast.

First Lieutenant George L. Harstuff and his band of 12 "surveyors" came across a large banana patch and summarily chopped it up, eating their fill and packing some along for the road. This angered Chief Bowlegs, and on Christmas Eve morning of 1856 he tracked the party down, killing four and wounding four more.

Then in February of 1857, the Chief and a group of warriors set on the Whitaker's place south of present day Indian Beach Drive. Billy Bowlegs was familiar with this home having visited the

Some would say the Whitakers and the Chief were on friendly terms evidenced by the Chiefs commitment that if he ever had to kill them he would do it quickly.

Maybe that is what he was prepared to do on this provoked and violent visit because he burned down the house and slave cabins. The family had earlier escaped to the Manatee River but one old Irishman known as Owen did not leave and was killed in the fire.

By 1858, Billy was out of steam and accepted relocation from the U.S. Government. He and his daughters moved to Indian Territory in what is now Oklahoma or Arkansas. He died in 1859 at 49 years of age.

It's interesting to ponder where the

famed banana patch was and speculators put it in a number of locations up and down the west coast of Florida. Could it have been in Sarasota? Or could this idea have been generated by developers Katherine and Daisietta McClellan? We know they were inspired by an Indian mound on their property when they developed McClellan Park in 1916. They used Seminole words to name the streets and had an Indian theme in the community clubhouse.

Winston Churchill said "History is written by the victors." In Florida this might typically be developers, but I prefer to believe Chief Billy Bowlegs considered Sarasota one of his homes and regularly visited a centuries old banana patch south of Hudson Bayou. If you don't believe me, I can show you the bananas on 41st Street.

#### **BEAUTIFICATION COMMITTEE NEWS**

#### **Pipevine Swallowtails**

The next time you are outside and see one of these, it could very well be one from our Greenway, (Sarasota Ave and 45<sup>th</sup>). It is the Pipevine Swallowtail, and you can see them in South Florida from February through November.

In late spring, the volunteer beautification crew was at the Greenway weeding and trimming. We were fortunate to see the pipevine clambering with activity from caterpillars. Beautiful! Chocolate brown with dark black stripes, tipped with orange spike-like nodules perfectly arranged on them. I snapped some photos and thought a brief synopsis of the butterfly was newsworthy, since something so beautiful to look at was right here in our neighborhood.

During breeding season, the male Swallowtail patrols a territory waiting for a female. Females lay clusters of one to twenty reddish-brown eggs on the host plant leaves. The caterpillars eat the leaves, stems, and seed capsules of the host plant.

Caterpillars are small and stick together when they are first born. They eat the leaves of their host plant and grow quickly. Plants in the Pipevine family have chemicals in them which are poisonous to most animals. Caterpillars eat them without being harmed.

When caterpillars are grown, they look for another place to pupate (resting stage). They never pupate on their host plant. They can also take up to 14 months to eclose (emerge).

The Pipevine Swallowtail is difficult to identify, as several other butterflies have the same size and colors. Pipevine Swallowtails can have wingspans up to three and a half inches. They are black with bluish-green metallic color on the hind wings. Females have a row of yellowish-white dots, males don't. When a Pipevine Swallowtail folds its wings while resting, you will see a curved row of bright orange dots underneath its wings.

As adults, Pipevine Swallowtails' food is flower nectar. Some of the flowers they visit include honeysuckles, milkweeds, and thistles. They also help by pollinating the plants.

Pipevine Swallowtails are helpful to other butterfly species because adult butterflies are poisonous to predators from all the pipevine they eat. Other butterfly species have developed mimicry. Some species that mimic Pipevine Swallowtails include Eastern Tiger Swallowtail (females), Eastern Black Swallowtail, Spicebush Swallowtail, and Red-Spotted Purple.

#### **REAL ESTATE NEWS:**

As of May 25, 2014 there were 38 homes listed for sale in Indian Beach-Sapphire Shores. True to form, these range from \$119,000 all the way up to \$13,800,000.

Currently, there are nine homes under contract to be sold. Fifteen properties traded hands since January 23rd. These sales ranged in price from \$95,000 to \$2,950,000.

The percentage of Distressed and Bank Owned Properties continues to decline as values increase, relieving homeowners who may have been "underwater" on their mortgages.

Of these 62 properties Listed or Sold below, only three are advertised as Short Sales and four are/were Bank Owned; a result of foreclosure.

Expect to see another demolition or two in the coming months, resulting in new home construction. The big news for IBSS is the pending sale of The Homes of Indian Beach.

Bank of Commerce put the property under contract with an out of state developer who specializes in small subdivisions of this type. The Buyer has completed their investigations and as I write this they are "moving to close" some time in June, 2014. Their intention is to build single family homes on the existing lots. Keep an eye out for signage and promotions. They seem to be realistic how long it might take to sell 23 new homes in IBSS, but they won't want to waste any time fishing for prospects. *David Jennings*

companies in Brazil, Ivory Coast, and Cameroon, and refineries in the latter two. I representated Texaco during nationalization claims and privatization projects. I also taught English to migrant and immigrant workers and children.

Why did you choose the IBSS neighborhood, and how long have you lived here?
We have lived on Sapphire Drive for 15 years.
We enjoy the peace and quiet of a picturesque location on the Bay; the wonderful ambiance created by the Ringling Museum, Asolo
Theatre, and New College complex; the beauty of Bay Shore Drive; and the wonderful mix of the divergent demographics of the people living in the area. We were surprised to see so much wildlife in a residential area: song birds, hawks, eagles, owls, frogs, snakes, foxes, raccoons, possum, and the first rabbit after its absence of four years.

Do you have family living in Sarasota? Outside of Sarasota?

We have no family in Sarasota. We have three children. Our son was born in a house in Africa and moved with us to the United States when he was ten years old. He now lives in Norwalk, CT and has a newborn daughter. Our two daughters moved with us to Africa when they were two-years old and one-year old. They moved with us to the United States when they were entering their senior year in high school and college. Currently, one daughter lives in Oslo, Norway and has a daughter and a son. I enjoy books by Evelyn Waugh, John le Carré, Thomas Merton, Flaubert, Tolstoy, Dostoyevsky, Nikos Kazantzakis, Joseph Conrad, and poetry by E.E. Cummings, W.H. Auden, T.S. Elliot, and Robert Frost.

Favorite painters are Rembrandt, Rouault, Braques, Van Gogh, El Greco, Kandinsky, Goya, Rothko, and Klee.

We rely on law enforcement to protect the residents of our community and the city Police to patrol neighborhood streets, apprehend criminals, and respond to our calls for assistance.
