

### **BEACH PROMENADE**

This is an update of our progress on the Promenade to be constructed at Bay Shore Road and Virginia Avenue. A new drawing has been made by Norton Rock to establish the concept, and this will be given to the City Engineering Department to develop working drawings so we can get bids from contractors to construct the walkway and stairs to the beach.

A few of our neighbors have sent in or pledged funding for this project. To date, the sum of \$2,400 has been assured. Of course, this is the beginning, and we are confident that many of you will contribute to this beautiful Promenade for our community to use and enjoy for years to come. We are fortunate for this beach asset; however, it has been left unkept, but it has the potential to become a beautiful and relaxing area for all.

With full understanding that an improvement like this is used and enjoyed by some homeowners more than others, it was suggested that we have various categories of contributions from \$10.00 to \$25.00, \$50.00, \$100.00, \$500.00 or \$1,000.00 so that the burden can be shared by all. # RED ALERT!!! RED ALERT!!! RED ALERT!!

Do you want planes to fly either directly over your house, or close to your home? If not, and I certainly do not want that noise or pollution any closer to my home than it presently is, you had better read this alert and be informed as to what is going on. I'm certain that there are many of our 1,000 plus households in our Indian Beach/Sapphire Shores neighborhood, who have read the articles that have appeared in the Longboat Observer and in the Bradenton Herald. For the benefit of those who have not read the articles, the Herald's headline read, "Longboat wants jets to fly slower, elsewhere". They state that the Sarasota - Bradenton International Airport officials say the plan could be impractical and dangerous. Reducing jet speed could create a safety hazard. Nyle Marmion, a noise abatement technician stated it might work on paper, but when you're flying a big jet it doesn't work the same way. A lot of pilots don't like the idea of reduced speed. I'm all in favor of safety first.

This proposal will be presented to the airport authority during its next meeting on March 15. I plan to be there. I need more interested neighbors there. I can not fight this battle alone. The meeting starts at 11 a.m., and is held in the Jeanne McElmurray Auditorium off General Spatz Ave., where the old branch post office used to be.

The next meeting of the Noise Abatement Advisory Committee NAAC, is April 1, 1993 at 1:30 p.m. at the same place.

We not only need people to attend these meetings, we may need individual letters and petitions in the future. Let me know if you are willing to join the fight against this proposed (hope it never comes about) change. If we remain vigilant as the Bird Key Association is, we may win. Let me know if you are willing to help. We used to have a member of our Association, Mr. Alan Lillie represent us on the NAAC: but, we have no one appointed to that committee now. No one to apprise us as to what is going on that might affect us. We must unite in an effort to defeat this proposal if the NAAC doesn't. If you see anymore on these issues, let me know. I may be out of town when something surfaces.

Below is a copy of the letter your Association sent to the NAAC. They have been very helpful to me.

Drear Mrs. Murphy:

It has come to the attention of the Indian Beach/Sapphire Shore Associaton, that represents over 1,000 single family homes, that a change in takeoff flight patterns has been proposed by the Town of Longboat Key. It is our understanding the at the Longboat Key Delegation proposes that all southbound aircraft taking off from Runway 32 execute a sharp left turn immediately after take-off so as to remain tin the middle of Sarasota Bay while climbing in a southerly direction. This routing may help reduce the noise levels on Lonbgoat Key, however, it will most assuredly affect our neighborhood as well as the Bird Key residents.

We are concerned that such a change may have an adverse effect on members of our Association by increasing noise pollution and posing safety hazards due to low-level operation over residential areas.

We strongly oppose this change which would increase the noise level of departing jet aircraft from the airport and runs counter to the noise abatement policies. We urge all concerned that the current flight patterns be retained to cause the least disruption to homeowners in the area. Thank you for your attention in this matter.

I hope to attend the April 1, 1993 Noise Abatement Meeting and personally argue our objections to the Longboat Key proposal.

#### NEIGHBORHOOD WATCH NEWS

The second annual city of Sarasota Block Captain/Coordinators meeting was held in February. We were given statistics comparing crimes committed in 1992 to 1991. The total calls for police service increased three percent in 1992 over 1991. The following criminal activities saw an increase in 1992: Burglary (3%), Larceny (1%), Auto Burglary (7%), and Auto Theft (32%). The best news was that criminal activities considered to be violent decreased in 1992. These included Rape (-14%) and Robbery (-11%).
