SAPPHIRE SHORES PARK RECEIVES NEEDED FUNDING

The proposed renovation of Sapphire Shores Park has required many hours of planning and time consuming work. It is close to becoming a reality. Recently the City of Sarasota and the Selby Foundation pledged their financial support for the beautification project if the neighborhood will raise an initial \$6000.00. Bob Bell and Alan Lillie are heading up the fund raising campaign.

Improvement costs have been estimated at \$60,000.00. The City's Public Works Department will act as project manager with work scheduled to begin in the fall. The City will assume responsibility for maintenance of the area once it is landscaped.

The proposed park will not only create a lovely space for waterfront viewing and strolling, but will enhance the quality of our lives and improve the our property values. Sapphire Park will reflect the artistic/educational character that this area represents. In adddition, use of the public land will be controlled by limiting parking to specific areas and times and providing litter control.
