Many of us are busy during this season so we will postpone any meetings unless there are pressing issues to discuss.

# Kitty

# 22<sup>nd</sup> Street

The local neighbors have agreed to allow the City to trim so I have re-requested a courtesy trimming. Todd K. has requested a service order. Recently some very colorful graffiti has appeared on the private wall. It is, however, on private property.

# Alameda ROW

Our requested trimming was done and a service order for the fence removal was created. One carrotwood was on private property, according to the crew so could not be removed by it.

## 40th Street ROW

A small plastic table and chairs was placed near the water for a time but has since disappeared. The plants look healthy and sprouting and some oak leaves were deposited near the pathway. Beau Com requested a bollard to replace the red sign which is there now. Todd K. is working on having one installed.

## Indian Beach

I met with Tony Russo, an engineer from Coastal Tech and a compliance representative to review the Indian Beach signage and our "wish list." The engineers have been chosen (the same ones who installed the last revetment 10 years ago) and they will try to implement our requests. Most of the palms should be able to be protected, but we may lose the ones too close to the edge of the beach. They are the ones which are threatened by nature anyway if there is another strong storm. The Public Works crew is discouraged by the intense dog destruction of their new plantings. I mentioned that perhaps we could try some new transplants closer to the rainy season when the "deposits" would be naturally rinsed more easily. I have also requested in the newsletter that dog owners steer their pups away from the new plantings. There was some, rude graffiti on the private wall but the owner quickly painted it out. I have contacted the former Police Department graffiti officer. That position is no longer filled but she gave me some good advice. Apparently, "OFF" will remove a lot of marks on plastic or metal. She believes the homeowners across from Indian Beach used to paint out the graffiti which occasionally appeared on the "seawalls". They have since moved away. I have purchased a couple of cans of spray paint (green and brown) to block out the small amount of markings on the planter beds near the water and the wooden box on the north end of the beach.

#### The Greenway

The debris has been removed, the crew trimmed, and we are now manually removing any weeding that we do each workday. We are still digging torpedo grass which has very deep roots. The City sprays weeds in that area and has sprayed this grass a couple of times. This will slow down our planting of new butterfly larval transplants, but we need to wait for more rain anyway. We have a schedule set up for watering so that the burden is shared and are amending the soil with donated compost and oak leaves. Joanne has begun re-working the brick work to better define it and help make future maintenance easier. The one rain we had washed over the old, sunken brick quite badly. Monica Neligon has donated a number of prize-winning bromeliads in memory of her mother-in-law so, along with the new spring sprouts and blooms, we have something to look at. We are amending the soil (it is mostly sand) with organic matter as we weed. **Lift Station 9** 

Patty P will request that the watering schedule be decreased to prevent the ponding. It is now on a daily schedule to save the sod, but we are getting nettles and many wet spots. The City has moved a few of the plantings and removed a few which did not survive the transplant. The swale cannot be sprayed because of the need to allow the cordgrass to survive, so I have volunteered to pull and "scuffle hoe" to keep down the weeds. I pointed out the Brazilian Pepper and Carrotwood to her and she said that they would "have to" remove them if they were on City land. I told her that it was pretty clear where the boundaries are now that the new fence has been installed, but that the neighbor behind the station would object.

#### **Sapphire Shores**

The newer trees seem to be surviving although the one furthest north is a bit brown. New sea oats are getting established. **Ainsley Place** 

The mimosa has come back nicely. The Beach Sunflower is a big "leggy" but is blooming nicely.

#### **Marlin Conservation Square**

I accidentally took home Dr. Miller's sign placing tool so will be visiting in the near future to check on Carrotwood at the street and return his tool.
