



One thing is wrong, not enough of you came. Attendance was down from the 325 we had two years ago.

Dear Bayshore Area Residents,

I am a New College student, and I am writing you to talk about noise. First, I'd like to apologize. The 3:00 A.M. "parade" down Bayshore about a month ago was really a bad idea. I understand that some of you thought that we were rioting, or that we were coming after people who had complained about the noise. Thinking back to the sights and sounds of a hundred students with pots and pans and garbage can lids, the fear is understandable. We are very sorry. It was nobody's intention to scare you that night. We were angry, not with you, but with the Sarasota Police and our own administration. The march down Bayshore happened after two hours of protesting on our own campus went unnoticed.

Secondly, I'd like to apologize for the noise in general. I don't know how many of you have been consistently bothered by our Walls (the late-night parties that until recently we had most Friday and Saturday nights). We really have no desire to wake anybody up at night or to disturb anyone's peace. While we've known for a long time that we have a problem with "noise complaints", only during the face-to-face conversations some of us have recently had with disturbed residents did it really hit home just how bothered people have been by our noise. Some courageous neighbors told us with passion and eloquence just how angry they have been made by the incessantly thumping bass of our week-end revels. We chose to remain oblivious to how real that noise problem has been for some of you.

For the moment, the problem is gone. The New College campus has been effectively silenced. A ban on any outdoor amplified sound after 10:00 P.M., and on any sound they consider to be excessive at any time of day or night has been enforced. This new administrative policy goes well beyond what is called for by Sarasota Noise Ordinance. We were given a lot of time and a lot of leeway to handle the noise problem, and we took that leeway and hang ourselves.

But, we really are hurting. It is difficult for people to understand what these "Walls", these loud, outdoor parties, mean to us. They were a way to "let off steam", a way to release some of the pressures of a pressure-cooker college. To some of us, Walls have been magical events, rituals of communion with our friends and fellows. New College is a small and intense place; everybody knows everybody, but we get pulled apart in different directions by a thousand books, classes and papers. On the weekends, we would all come together and dance, beneath palm trees, moon, and sky. It is difficult to describe what a beautiful and important thing this was to some of us.

This doesn't give us any right to disturb you. I cannot justify our intensity. While we've made attempts to keep the sound down, it's hard to control the volume at a party of two hundred people. It's difficult to know how loud is too loud, because of how much the noise problem seems to vary with the weather. Because our attempts at controlling the volume didn't seem to work, we were afraid our administration would demand of us more drastic solutions, and they did.

The campus is in a state of shock over the lack of Walls. We lack a center, any place where we can all get together. Students have tried heroically to find ways of filling the void: we've had coffee houses and parties off-campus; we had the Jazz Wall that IBSSA was invited to but was dulled by rain; we've tried to have parties in such unusual places as our racquetball court. Some of these events have been quite successful. Late on Friday and Saturday nights the campus is deadly silent; occasional clumps of drunken wanderers comprise the only visible social activity. To someone who has for three years experienced the festive bustle that previously overtook the campus, this is very sad.

We are working to find ways to deal with the noise problem effectively, so that we could have our Walls, and you could sleep. Over the next few weeks, we will be conducting sound studies; we may have an outdoor location that is effectively acoustically isolated from residential areas. We are looking into the possibility of purchasing acoustical barriers, such as noise-reducing curtains. We continue to await the construction of a long-promised berm that would hopefully cut down the noise reaching Bayshore residences, as it seems to have done in Upland residents. Hopefully, some of these ideas will bear fruit.

So, again, sorry for whatever we've wrecked, either with our continual noise, or by our little "parade" of a month ago. I hope that these problems haven't left a great aftertaste of animosity between the neighborhood and New College students. The meetings we've had this year when we've gotten together at the Jazz Wall or the Association picnic all suggest that, on the whole, we seem to like each other pretty well. Some of the neighbors I've spoken to have distinguished themselves as extremely nice people. Your officers and Board of Directors asked many excellent questions and offered some good suggestions. I hope that some of us students have done the same. For the many times you've tolerated our excesses, thanks.

NEW COLLEGE/USF NOISE PROBLEM. Many of your are aware of our "noise pollution" problem via articles printed in the Sarasota Herald, and the Times. Our family is prepared to file a a suit if there is any more noise. Several other families have said they will support the suit.

Several meetings have been held in an attempt to solve the problem: 1) with the police, 2) with the students and administrations Campus police.

Some arrests were made as a result of their demonstration. The students requested space in our newsletter to apologize to the offended. Our Board of Directors heard the letter, and although its' quite lengthy, we've agreed to print it in a slightly shortened version.

NEWS ON SAPPHIRE SHORE PARK

The first phase of our parks beautification program has now been completed. We're delighted to see its increased use by strollers and bench loungers. For those of you who haven't yet visited - please come and enjoy.

As for our new plantings, some are doing better than others. A few of the live oaks are in shock and may have to be replaced (at contractor's expense). Also, quite a bit of the Bahia grass seeding hasn't germinated and rye grass seeding may be necessary to temporarily hold over till next spring. Additionally, there has been some parking on the seeded area at the extreme north end of the park. The City has requested that we ask everyone to park only on the street.

Your Association would like to adopt the park under the auspices of Keep Sarasota Beautiful. However, we will need volunteers to regularly walk the park, picking up trash, checking for damage, etc. We'd also like to hear from any avid gardeners who would like to donate their time (and plants, maybe) to installing and tending to few small planting beds. We will be printing a park donors list early next year in appreciation of contributions made by so many of our members. If you have not already given, you may still participate in this fine neighborhood project - we still need funding to complete the landscape design so continued support will be most helpful.

Don't forget about Keep Sarasota Beautiful's "Trees as a Living Legacy" program. This is a lovely way to create a living memorial or to commemorate an event. Donors may select the type of tree to be planted and plaques are included in the set fee. Sapphire Shores Park would be an ideal location.

***** NORTH TRAIL SECTOR STUDY MEETING ***** November 26, 1991 7:00 p.m.

If you live close to the Tamiami Trail, or in the IBSSA Community, this may be the most vital meeting you'll ever attend. Mark November 26, 1991 7:00 p.m. on your calendar. This meeting will present the final stages of the North Trail Sector Study and will be held downtown in City Hall, Room 303A in the Annex. The Planning & Development Department has commissioned Joe Cooley of J.L. Cooley & Associates for assistance with the final draft of the new "NT" zoning district. Joe lives in our neighborhood.

If you do not make your feelings heard at this meeting, don't be surprised or complain if the density along 41 is increased or it the percentages of impervious land use doesn't meet with your approval. We've had lots of opportunities to meet with this Study group; but, very few of you have ever shown up. It's the zoning changes that should be of interest to you.

You may review the draft by visiting the Planning Dept., Room 300, City Hall Annex, the preceding Friday of the workshop in the event that you cannot attend the workshop itself because of a conflict.
