HI NEIGHBORS !!!!!!!

We are now well into another year and the work of the association seems to never cease. But, I have come to the realization that the

more things change, the more they stay the same. As an example, I was reviewing some of the association's minutes of meetings and read where your board of directors had discussed asking the city to improve the landscaping around the sewer lift station on Bay Shore Rd., repaint the street lights along Bay Shore Rd. and to restripe the center line of Bay Shore Rd. These items had been discussed in our January 9th, 1996 board meeting, however, the minutes I was reading were written on January 25th and February 8th. 1956.

At the time of this writing, the big news around the neighborhood is the closing of the Publix store in North Trail Plaza. Your association made many phone calls, signed petitions, appeared on television and wrote many letters as did The North Trail Association, The Downtown Association, Gateway 2000. The Ringling School of Art and Design, the City of Sarasota and many others, but to no avail. It now appears that the decision to move out was cast in stone and deals were in progress for subleasing the space and selling the equipment months before the announcement was made. Therefore, we were never given the opportunity to plead our case. If you are looking for someone to blame, fingers can be pointed all around. First, there is little argument, that the property owner was and is less than cooperative. The needs of this neighborhood were not part of his agenda. We feel that Publix did not give this neighborhood, which has supported their store for many years, the chance to work with them to turn the profit picture around. We were told the store was not too far from turning a profit, but still little effort was made to improve the store. The finger of blame can also be pointed to ourselves for not giving the store more support. I know many did not shop in this Publix because it lacked variety in stock and some of the amenities of other stores, but maybe, just maybe, if our support had been stronger, Publix would have made a better effort at remodeling this store. This, of course, is all speculation, but I am positive about three things: 1. The closing of this store affects all our property values. 2. Our task of improving the quality of the North Trail just got harder. 3. WE WILL NOT GIVE UP ON THE NORTH TRAIL.



NEIGHBORHOOD WATCH NEWS By Debbie Muller

Three burglaries were reported in our neighborhood during the first three months of the new year. Two of these occurred during the evening while the residents were out for a short time. The burglars gained entry to one home on North Shore Dr. by breaking a small window, and to the second, on Bay Shore Road, by breaking a pane of glass in a door. Money and jewelry were among the items stolen. Fortunately, in one case, some of the possessions were recovered due to the arrest of a burglary ring. In the third theft, on Stevens Dr., items were taken from an open garage while the owners were at home. Remember that most criminals are opportunists. The most effective deterrents to these intrusions are concern, awareness and communication. Remember also that lighting around your house is one of the best deterrents.

Bill Zuk, coordinator for Sapphire IV, is no longer able to serve and is in need of a replacement. GUEST EDITORIAL BY

CITY COMMISSIONER NORA PATTERSON

I am delighted to have the opportunity to bring a few bits of news to you. You live in one of the most politically aware city neighborhoods, and I will touch on a couple of areas you may find of interest.

People living in the Sapphire Shores/Indian Beach neighborhoods have long been waiting for the City to do away with the adult entertainment establishments along the North Trail. The City passed two ordinances, surrounded by controversy, with the intent of bringing relief to affected neighborhoods. One ordinance prohibits nudity at establishments selling alcohol. Another, created a ban in most zone districts, including the North Trail, on all adult establishments. We were as restrictive as our legal staff said we could be and still defend the ordinances in court. We allowed one year for the existing businesses to disappear, and you may be wondering why such businesses are still in place. We are currently fighting numerous lawsuits and we cannot close these places down until the litigation has been resolved. Some of these have voluntarily ceased to do business.

Sherry Plaster Carter won a national award for the North Trail Ordinance that many of your neighborhood leaders helped to construct. A significant part of the focus was on controlling crime through environmental design that promotes visibility and sight lines in a concept called CPTED. The Ringling School of Art and Design was the first participant when it enlarged it's facility. According to Sherry, crime in the North Trail district has dropped by 29% from 1990 to 1994. Chief Jolly confirmed these statistics. Although there is much to be done to rejuvenate the commercial corridor, and crime is higher than we would like, statistical progress and national recognition are encouraging. Now if we could only figure out how to keep Publix in the immediate area. The good news is that Winn Dixie is remodeling.

City taxes will be substantially down this year, and lower further over the next three years because of fire consolidation with the county. A fire fee, however, will replace some of the savings, and for the less highly valued homes there may be little or no savings for this year.




