In March we worked with the Ringling Museum on traffic control for the Medieval Fair. As a result, the traffic within the neighborhood was easier to live with.

The city of Sarasota has seen a 14% decrease in the number of serious crimes committed as of October 1994 and a 14% increase in the number of arrests made. We have had a number of auto and residential burglaries in our neighborhood. Many residents are very concerned by the numerous solicitors in our Most recently these have included magazine sales (after dark), yard work (no equipment) and requests for money to make car repairs or buy gasoline. Always ask for identification and let solicitors know that all suspicious activity in our neighborhood is reported to the police. Working together we can keep our neighborhood a very special and safe place to live.



ADULT ENTERTAINMENT ORDINANCE PASSES


On October 3rd, the second and final reading of the Adult Entertainment Ordinance was passed by a 4-to-1 vote by the Sarasota City Commission. At one point during the meeting, appeared that the Commission would consider increasing the distance required between these businesses and residential properties. It was quickly pointed out by the City's planning and legal staff that such a change would, in fact, eliminate possibilities of ANY adult businesses operating within the City. While this is a situation we would all like to see, the ordinance would surely be overturned in court "violation of the First Amendment rights". Finally, after much discussion and legal counsel, the original ordinance was voted on and passed intact. It requires all, except one, of the existing businesses to close within one year, and ALL businesses must comply with the regulations of the ordinance within 90 days. The one business which presently complies with the ordinance is located at 2092 17th Street.

The City, our association, and many others have worked very hard to get something on the books that would control these businesses, but the battle will not be won until the ordinance has stood up to a court challenge. One of the major points the courts would consider is whether the business creates any secondary effects". The "adverse obvious adverse effect of our close proximity to these businesses would be a decline in our values and the reluctance property buyers invest to neighborhood. We, who live up here, have long endured these negative comments reflecting just such reluctance, and of course, these unsavory businesses play a big part in that. In the likely event that the ordinance is challenged, it would be well for us to have such documented information on file to protect our position. You, especially you neighbors who are realtors, can help by writing down any such comments you hear, citing names, dates, places and as much specific information as possible. Send it to the association or call it in to your president or any board member, and hopefully, when the time comes, we'll be ready for the challenge.


AND THE BAND PLAYS


A POEM BY PEGI CLARK PEARSON

I DANGER I

While trying to update our mailing list, we have become aware of a potentially dangerous situation. We found that the numbers on many houses are difficult to locate; some have numbers on the mail boxes only, and some do not have numbers anywhere. A county ordinance requires that numbers be placed on the residence in full view, be of a contrasting color and be at least 4 inches high. The ordinance provides for a fine for failing to comply, but what really concerns us is whether the police, fire or rescue service could easily find your house in case of an emergency. As you know, the house numbers in our neighborhood do not necessarily follow in sequence, making it all the more difficult to locate a residence. Drive by your house, as an emergency vehicle would, and see if your number is readily visible. Remember that seconds could mean the difference between life and death.

If you are physically unable to apply the proper numbers, and are financially unable to hire someone to do it, please call one of the association officers. Maybe we could help.

DUAL TAXATION

DUAL TAXATION ... Two words you will be hearing often during the coming year, especially from this forum, as I have pledged to dedicate considerable time and effort to the issue. Since I think it is so important, what is the problem and what can we do about it?

Dual taxation can be made into a complex issue, but for those of you who are not familiar with the issue, I will keep it simple. The problem IS simple, but more often than not, the people who could remedy the situation make it very complicated to avoid doing what is fair for the residents of the City.

Dual taxation occurs in Sarasota because we, as residents of the city, pay the same county property taxes as county residents. We also pay city property taxes from which county residents are exempt. In other words, we pay our full share of county taxes but must carry the burden of operating the city alone.

In past attempts, the inequity has been only partially resolved by the county maintaining some city parks and rebuilding certain regional roads such as Tuttle Avenue. However, the really big inequity still remains, and that is the County Sheriff's road patrol. We, in the city, pay the county about \$2.5 million each year for this service from which we get little or no benefit. There are a number of items in the sheriff's budget that we are happy to pay for, but the \$2.5 million is for the patroling of roads only. In a court case the judge ruled that we benefited by the sheriff's deputies passing through the city on their way to patrol the county. To pass through our neighborhood, the deputies would have to be really lost.

What are the solutions? One would be to turn city policing over to the county. At times ordinances are confusing enough by themselves, but when you ask deputies to enforce two different sets, it may be asking too much. Besides, this is one more step toward total consolidation, which, personally, I am not ready for. I believe that our city government is more responsive to our needs simply because it is smaller.

Another solution would be to take the matter to the courts again. We have been down this road before, and it was not successful. Courts decide legal matters and this is not a question of legality .. it is a question of what is fair and just.

I think the simplest solution would be for the sheriff to make the cost of the road patrol a separate line item which would not appear on the tax bill of city residents. This may be too simple and we will continue to explore other ways in the coming year.

What can you and I do? In the past, efforts to solve this issue have been initiated by city government with the support of only a few from the public sector. This time we must turn it around and make it a public effort strongly supported by the city. The county commissioners are not unreasonable, but we must make them aware that we know an inequity exists, and that we care. Your job will be to make yourself aware of the facts, and spread the word to everyone who will listen. LET'S GET IT DONE !!!!

THERE'S TROUBLE ON 58th STREET

For those who are not familar with 58th Street, it is a small private street with 9 houses bordering on the south side of The University of South Florida/New College's west campus. It had it's beginning as the drive to the estate of Charles and Edith Ringling situated on Sarasota Bay. It is for the most part unpaved and resembles a peaceful dead end country lane.

The tranquil life our 58th Street neighbors have enjoyed for so long now threatens to be a thing of the past. It seems that the proposed USF/New College Master Plan includes a scheme to develop a large "loop road" that would enter the campus from Bay Shore Road on the north, loop around in front of College Hall on the Bay and rejoin Bay Shore Road on the south side of the campus through what is now 58th Street.

How can this happen? It seems that in 1969, the executor of Edith Ringling's will, through mistaken generosity, deeded 58th Street to New College, so, in fact, USF/New College owns the street. Owning the street, the University feels it must do "what is best for the University" even though it would destroy life on 58th Street as the residents know it, to say nothing of their property values.

The 58th Street residents and your association sincerely regret the loss of good relations with the university that have built up from the many years of living in harmony together. There has been one public hearing on the master plan, and two meetings between Campus Dean David Schenck and the 58th Street residents, with no change in position on either side. Your association has attended all of these meetings, and will continue to give all the support we deem feasible.
