Charlie (attorney) listed many improvements that have been added to the plan. Kevin thanked the developer and attorney. Adding additional parking spaces, implementing bubblers and a rain garden (swale). 309 parking spaces in all. Keeping some grand trees, including the one on 42nd street. More vegetation for buffers. Fence will be sand-colored PVC. 25 EV charging stations. Tim Thurman recommended they look into a denitrification process for the runoff going into the swale. FDOT suggested that they may need to move the north egress/ingress to north boundary of the project. If so, the north and central buildings will most likely become one larger unit to allow the new driveway opening.

Neighbors commented on pets, parking, etc. Pedestrian access only available on Sarasota Ave. Jay Patel offered to donate to our Greenspace fund.

Update regarding the bids for the Greenway.

We have three full bids on the table and may need a vote for expending funds.

Graber \$15,800 (all inclusive)
Tony and Sons \$11,553 (requires fill, hydro-seeding)
Yellow Dog, \$11,696 (requires fill, hydro-seeding)

We have \$10,000 grant. Hydro-seeding is about \$1,000. Fill is additional and only addressed in the Graber quote.

Sean is following up on some clarification with Graber and the 2 other quotes.

Henry moved to vote that we move forward to review Graber's contract and review the Board Insurance. Kate seconded. Discussion included whether the Board's insurance policy covers us in the event of an accident during the work. All voted in favor.
