Another Terrific Trifecta on Tamiami

While **Antojitos Cuban Cuisine** "existed about a year ago", the restaurant has blossomed since new owner, Jennifer Ortega, arrived some months hence. Inviting is the bright orange Havana Chevy beckoning from Tamiami Trail. Jennifer owned a restaurant in Cuba before coming here. An outdoor terrace complements the spacious indoor dining area. Open from Tuesdays through Sundays, Jennifer said, "We have happy hours Tuesdays through Thursdays with special beers. And we have live Cuban music on Fridays and Saturdays." The bands feature "Cha Cha and Samba". Mojitos and margaritas go well with the Cuban music.



Ceviche, calamari and shrimp are among the main aperitives (appetizers). "Frito del mar" (fruit of the sea) pasta is popular. Cuban sandwiches supplement pork, chicken, beef and fish "principales" (entrees). And there is a kids' menu with chicken tenders and fish and chips. An unusual activity is dominoes on Sunday afternoons. Plus, there is take-out, too!



In the *everybody converges in Sarasota* category, **Fork and Hen** co-owners, Alfonso Buron and Mark Traugutt come from Mexico and Brooklyn, respectively. While both have been chefs for about 20 years, they have worked together for 12. This includes restaurants in this area. The name, Fork and Hen, came from their collective brainstorming. The menu and drinks reflect both of their preferences.

"Everything on our menu we love", Mark said. "People like the fried chicken especially. And our audience is everything from college kids to retirees." Take-out also sells well. Open Wednesdays through Sundays for lunch and dinner, there is an outdoor patio with picnic tables and umbrellas. Inside has seating at tables for two or four. "Since we opened last May," Alfonso said, "we expect to have a big party and celebration soon." Quality beers, mimosas and house wines will flow.

While **The Reserve and Hotel** has operated for six years, the buildings were Ringling family houses that were transported to the Trail nearly a century ago. Generous outdoor spaces complement indoor areas. Sarah Simmons has been General Manager almost from the start. From Fort Myers, she has been in the restaurant business for nearly 30 years. "In addition to casual fine dining," she said, "we have monthly happenings. There is live music sprinkled throughout our schedule which includes jazz. There are also karaoke and open mic nights.



Guests of the "boutique hotel" can breakfast in the café. Lunch and dinner can start with fish dip and crab bisque, main courses feature steak, salmon, mussels and scampi. "We are open Wednesdays through Sundays," Sarah added. "And we enjoy participating in the city's special events like 'Savor Sarasota' this summer."

Reducing Homelessness Through Art & Design

Hello Neighbors,

This is my fourth feature in our neighborhood briefings! Yet for a refresher and any new neighbors: I'm Megan Howell, the executive director and founder of Second Heart Homes. Here's a little bit about our nonprofit organization. Our mission is to revive the dignity of the homeless and mental health population through housing, support and, yes, love. Our beginning occurred when I was going to college while waitressing at the locally famous Patrick's. I'm sure I waited on many of you. While working at the restaurant, I befriended a gentleman with schizophrenia who had been homeless for 25 years. It's a long story but I helped him get off the streets. Today, he is a retired homeowner, focusing on his art. He is also the genesis of what is now Second Heart Homes.





Today, we own 8 properties that are home to 49 men and women throughout Sarasota and Manatee counties. Imagine a room full of 49 people — all of them homeless. And now imagine yourself without a place to call home, hungry and without a safe place to lay your head. Without our help, these individuals would surely be going through a merry-go-round of emergency healthcare services, the criminal justice system and street life.

When you have a mental illness, you have a greater chance of becoming homeless. Alternatively, being homeless increases the

development and exacerbation of mental illness.

The truth is, all aspects of our community suffer when people are mentally ill. Businesses, neighborhoods, property values, tourism, resources, institutions and of course the vulnerable individuals and their loved ones are impacted. That's why what



we do is so important. We don't just provide a house; we provide access to hands-up services and an opportunity for interested individuals to achieve potential by turning the page on homelessness. We do this all without government funds and minimal debt.



We just celebrated opening our 8th home, which is for women in Manatee. This project was a testament to the power of community. Some of you gave your time and talent, whereas others stepped in with generous monetary support. A how's this

for a community-based dream come true: Ringling College of Art and Design students volunteered their expertise to make this home appear calming and inviting. All in all, when everyone focuses on what we all have in common, wanting homeless people off the street, we all win. As a result of 45 volunteers, donations, and love, we were able to create an art-inspired sanctuary. Art and design are not luxuries, they are vital essentials that provide the foundation for who you are and how you move forward.


It seems appropriate to honor one of our most storm-tolerant trees as we usher in hurricane season.

The native Gumbo Limbo is an important canopy tree in tropical hammocks. While we may be near its northern range, the largest known specimen is in DeSoto National Memorial Park in Bradenton. This behemoth is about 85 years old and 16 feet around at the trunk.

I've only seen the most tenured of our neighbors choose it for a landscape tree but someone from the City of Sarasota felt it was appropriate for Sun Circle Park where they placed four just off South Shore Drive. Strolling north along the bay, you might find

the older one planted in honor of longtime resident Dot Simpson in 2001. It has sustained some damage over the years but looks grand and still stands after several close calls with "named storms" and being fully exposed to northwesterly gales which march down the bay all winter long. I'm sure there's an analogy there that her son-in-law, Dick Clapp, could share with us.

Of course, the most common description of Gumbo Limbo is the "tourist tree" for its red peeling bark reminiscent of a sunburnt visitor. I would be remiss for not adding this, but more importantly the Calusa Indians had so many uses for this tree that early Spaniards interpreted it as "el palo para muchas casas", The Tree of Many Uses. The list of applications is long, but my favorite is "warding off evil spirits".

That covers everything in my book, including sunburn.

Indian Beach Sunset Event, May 2

Seventeen graduate students from the University of South Florida's School of Architecture in Tampa completed proposals to redesign the 500-foot-long Sarasota Indian Beach Park as their last assignment of the spring studio. The architecture students looked at strategies to better connect the Indian Beach Sapphire Shores neighborhood to Sarasota Bay and to turn the popular park into a more welcoming place for neighbors to meet. The individual models, built at a scale where an inch equals twenty feet, depicted part of the adjoining neighborhood. Each model measured forty inches long. The studio is taught by IBSSA resident and architect Michael Halflants.

Real Estate Sarasota-Golden Handcuffs

Have you heard the phrase, Golden Handcuffs?

It's getting used a lot right now to describe Homeowners reluctant to sell and move because they have such low interest rate loans. Why sell when your current mortgage is at 3% and a new loan might be 7%? Never mind that some Sellers have enough equity to make their next purchase with cash.

But for Floridians, this is not the first time we have dealt with *Golden Handcuffs*. Originally, it described those with Homestead Exemption on their properties. This "caps" the *increase* in taxable value at 3% per year or the Consumer Price Index, whichever is less. This went into effect around 1993, so for anyone who has owned their home since then, you are taxed at rate which looks like the market value more than 20 years ago!

The Golden Handcuffs meant, even if you could sell your home for multiple times what you paid, who wants to buy a new house just to experience an incredible increase in Property Tax?

This changed in 2008 when Florida approved a constitutional amendment introducing Portability of Homestead. It is a great benefit but received little attention in a market where values declined and plateaued for the next decade. But now we are back with higher values, and it is important to understand Portability.

Here is an example:

A home was purchased in 1992 for \$145,000. Because of the "cap" on taxable value, today this property is assessed at only \$300,000 31 years later! But the Property Appraiser recognizes Market Value is (at least) \$800,000 which leaves a difference of \$500,000. This is the "portable" savings, called "cap", on your tax report. If this homeowner sold the property and purchased a new home for \$1,000,000 the Property Appraiser would "port" this "cap" of \$500,000 to the new home, lowering the potential Assessed Value to \$500,000 (\$1,000,000 - \$500,000). If this homeowner "downsized" to a less expensive property, (a townhome for \$650,000?) the taxable value could be reduced by 62% ($$500,000 \times .32 = $208,000$).

One is called "porting up" and the other is called "porting down". Of course, all these details are subject to the Property Appraiser's approval, but future scenarios can be predicted.

So, before accepting the constraints of Golden Handcuffs make sure you know if there are any keys available which could unlock them.


